

 the Quirk Estate, this Prize remembers the lifetime of seminal contributions made to the
 field of sports economics by Professor Quirk, who taught at Caltech and the University of
 Kansas, and was of Irish descent.

Our awards also include the "Head of College Exceptional Achievement Award", with recipient nominated by the Deans of both Business and Law. It acknowledges a student who has had an extraordinary impact during their time in the College and made a truly unique contribution to student life. In addition, the College provides its own range of Quercus Scholarships at undergraduate level rewarding academic achievement. Leaving Certificate Excellence is acknowledged by the UCC Entrance Scholarships.

The wide range of awards presented reflect the work of the College, its relationships, and its history. For example, today a recipient will receive The Peel Memorial Prize, one of the most historic in the University. In 1861, Sir Robert Peel, then Chief Secretary for Ireland, initiated a fund to augment the endowments of the Queen's Colleges. Queen's College Cork subsequently became University College Cork at the start of the last century. This endowment continues to recognise the exceptional achievement of our students in what is now a very different world.

For all recipients, today's recognition of your outstanding achievements is testament to your excellence and the development of graduate attributes reflective of the University's core values. We congratulate you and wish you every success. Those of you now leaving UCC are encouraged to stay in touch with your lecturers, your programme staff, and your fellow students. 


Law Society of Ireland Annual Human Rights Student Competition
