# THE FDC GROUP SCHOLARSHIPS: TERMS AND CONDITIONS

PURPOSE: To support up to six students participating in the MSc in Co-operatives, Agri-Food and Sustainable Development and/or the MSc in Management and Marketing.

VALUE : € 12,500. Successful applicants must complete the placement element of the MSc programme with the FDC Group.

CRITERIA: To be considered for a competitive Scholarship, the following criteria must first be met:

- Students must secure a minimum Second Class Honours Grade 1 in an approved primary degree or equivalent.
- Students must have applied for one of the two applicable programmes via the Postgraduate Applications System (PAC), have received an offer and have accepted a place on either programme to qualify to apply for the Scholarship.
- This Scholarship is open to all EU students.

### **APPLICATIONS**

Applications for the Scholarships must be made on the official application form and include name, contact details and qualifications with graduating institution(s).

Applications must include a short personal statement in response to the following (max 500 words per question):

- Identify an important issue facing Rural Ireland at present and propose a concise strategy to address this issue.
- Outline in what way you could contribute to the development of Rural Ireland given the challenges identified in question 1 above.
- 3. Finally, outline
  - Your reason for applying and academic background.
  - Your previous achievements (academic or other notable achievements).
  - Your future career ambitions.

Applicants must name at least two referees - one academic and one professional.

CLOSING DATE FOR

APPLICATIONS:: Friday 21st August 2020. A short list of candidates will be sent to the FDC Group on or before Monday 24th August 2020 for review. Interviews will be scheduled for Tuesday 1st September 2020 and will take place at University College Cork. Once the Scholarships are awarded, successful candidates will be afforded three days to accept the Scholarship.

SHORTLISTING AND INTERVIEWS: Applications will be shortlisted by the Programme Directors to ensure all applications meet the necessary criteria. The Selection Committee will then interview the shortlisted candidates and award the Scholarships. Members of the Selection Committee will comprise of:

- Dean, Cork University Business School or their nominee.
- Two representatives from the FDC Group.

Applicants will be asked to meet the Selection Committee as part of a formal interview. Interviews will be conducted at University College Cork over one day; however, in exceptional circumstances SKYPE interviews will also be permitted.

#### ADDITIONAL TERMS FOR SCHOLARSHIP RECIPIENTS:

The FDC Group Scholarship can only be awarded to successful applicants who are self-funded.

- Scholarship recipients will pay the Semester 1 fee for the programme to UCC in September of the year of registration. The Semester 2 fee will be paid by the FDC Group Scholarship on behalf of the recipient subject to full payment of the first half of the programme fee by the recipient in Semester 1. On successful completion of the MSc programme, the recipient will be reimbursed for the Semester 1 fee by the FDC Group Scholarship.
- The remaining Scholarship monies, after allowing for programme fees, will be paid in 5 equal monthly instalments on commencement of the practice-based research project. In all cases, the practice-based research project will be undertaken at FDC Group offices.
- The Scholarship is only valid in the year for which the applicant applies for the Scholarship and registers for the MSc programme, that is, it cannot be deferred to another year other than in exceptional circumstances and wholly at the discretion of the FDC Group.
- Scholarship recipients will be required to complete a feedback form at the end of their MSc programme and, where appropriate, will be asked to provide a written testimonial and profile picture for promotional purposes.
